### 1. INTENDED USE

The influenza reference virus NIBRG-267 (H7N9) is a reassortant virus prepared by reverse genetics from A/Shanghai/2/2013 virus and A/PR/8/34 (H1N1) virus. The passage history is attached.

Country of origin of biological material: United Kingdom.

Each ampoule contains 250µl (nominal) of infectious influenza virus as allantoic fluid from embryonated hen's eggs.

### 5. STORAGE

Store in the dark at -70°C or below

Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.

# DIRECTIONS FOR OPENING

Vials have a screw cap; an internal stopper may also be present. The cap should be removed by turning anti-clockwise. Care should be taken to prevent loss of the contents. Please note: If a stopper is present on removal of the cap, the stopper should remain in the vial or be removed with the cap.

# 7. USE OF MATERIAL

A range of dilutions (e.g.  $10^{-3}$  to  $10^{-5}$ ) should be made in a suitable medium for initial cutivation.
