

**WHO International Standard** 1st International Standard for Human Papillomavirus (HPV) Type 6 DNA NIBSC code: 14/256 Instructions for use (Version 1.0, Dated 21/11/2019)

#### 1. INTENDED USE

The 1st International Standard for HPV Type 6 (HPV6) DNA for use in nucleic acid-based assays consists of a freeze-dried preparation of recombinant plasmid pBR322 containing full-length HPV6 DNA cloned via BamHI at nt position 4724 (located in the L2 gene) (Gissmann et al, 1983). The standard has been formulated in a background of purified human genomic DNA, lyophilized in 0.5 ml aliquots and stored at -20 °C. The material was characterised in an international collaborative study involving 15 laboratories (WHO/BS/2019.2360).

#### CAUTION

This preparation is not for administration to humans or animals in the human food chain.

The material contains DNA purified from human placenta (Sigma, D7011). As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

#### 3. UNITAGE

The 1st International Standard for HPV6 DNA (NIBSC code 14/256) has an assigned unitage of 1 x 10<sup>7</sup> International Units (IU) per ampoule.

#### 4. CONTENTS

Country of origin of biological material: United Kingdom. Each ampoule contains the lyophilized equivalent of 0.5 mL HPV6 plasmid DNA diluted in 10mM Tris buffer pH7.4 containing 1mM EDTA, 5 mg/mL trehalose and human DNA (~1 x 10^6 GEq/mL) derived from placenta.

#### 5. STORAGE

The ampoule should be stored at -20 °C or below on receipt. Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.

# 6. DIRECTIONS FOR OPENING

DIN ampoules have an 'easy-open' coloured stress point, where the narrow ampoule stem joins the wider ampoule body. Various types of ampoule breaker are available commercially. To open the ampoule, tap the ampoule gently to collect material at the bottom (labelled) end and follow manufactures instructions provided with the ampoule breaker.

#### 7. USE OF MATERIAL

No attempt should be made to weigh out any portion of the freeze-dried material prior to reconstitution

The 1st International Standard for HPV6 DNA contains high copy number template. There is a high risk of HPV6 plasmid DNA contamination via aerosolization upon opening of the glass ampoule. The material must be opened and handled in a separate laboratory environment, away from other pre-amplification components such as reagents, labware and samples.

The material is supplied lyophilized and, before use, should be reconstituted in 0.5 ml sterile nuclease-free water. Ensure that the inside

surface of the ampoule is wetted with the added water so that any particles of freeze-dried material adhering to the glass are reconstituted. reconstituted material has a final concentration of 2 x 10 $^{\rm A}$ 7 IU/mL. reconstituted material is suitable for calibration of in-house or working standards for the amplification and detection of HPV6 DNA (WHO/BS/2019.2360). The material should not be used to calibrate or assess extraction, precipitation or centrifugation procedures. NIBSC can provide guidance for the use of 14/256 in assays where the extraction step cannot be separated from the amplification step (e.g. sample-in, answer-out platforms). This material has NOT been calibrated for human DNA nucleic acid-based techniques.

#### 8. STABILITY

Reference materials are held at NIBSC within assured, temperaturecontrolled storage facilities. Reference Materials should be stored on receipt as indicated on the label.

Degradation studies on 14/256 indicate that the freeze-dried material is extremely stable and suitable for long-term (WHO/BS/2019.2360). Users should determine the stability of the reconstituted material according to their own method of preparation, storage and use.

NIBSC follows the policy of WHO with respect to its reference materials.
