Influenza virus infectious IVR-202

Instructions for use
(Version 4.0, Dated 10/12/2019)

1. INTENDED USE

Reagent 19/192 is prepared from IVR-202 (A/Christchurch/516/2019 x A/PR/8/34) which was processed for freeze drying in 250µl volumes as described by Campbell, PJ, Journal of Biological Standardisation, 1974, 2,249-267. The derivation and known passage history of IVR-202 is attached.

2. CAUTION

This preparation is not for administration to humans or animals in the human food chain.

The material is not of human or bovine origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

3. UNITAGE

No unitage is assigned to this material

4. CONTENTS

Country of origin of biological material: United Kingdom.
Each ampoule contains 250µl (nominal) of infectious influenza virus as allantoic fluid from SPF embryonated hen's eggs.

5. STORAGE

Store in the dark at -20°C or below

Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.

6. DIRECTIONS FOR OPENING

Vials have a 'flip-up' circular cap. Either on the cap or the collar of the vial, there is an indication of the point at which to lever off the cap. This exposes an area of the stopper through which reconstitution and withdrawal of the preparation can be made using a hypodermic needle and syringe. If use of a pipette is preferred, then fully remove the metal collar using, for example, forceps, taking care to avoid cuts by wearing appropriate gloves. Remove the stopper for access. Care should be taken to prevent loss of the contents.

7. USE OF MATERIAL

Reconstitute the contents of one ampoule of reagent with 250µl of sterile distilled water. Leave for a minimum of 5 minutes before use to allow for complete solution of freeze-dried material. A range of dilutions (e.g. 10⁻³ to 10⁻⁵) should be made in a suitable medium for initial cultivation.

8. STABILITY

Reference Materials should be stored on receipt as indicated on the label.

Derivation of IVR-202 A/Christchurch/516/2019– like High Growth Reassortant

A/Christchurch/516/2019 (IVR-202, Lot 442) is a H3N2 high growth reassortant virus.

PREPARATION

The preparation of A/Christchurch/516/2019 (IVR-202, Lot 442) high growth reassortant influenza virus was conducted in R&D Influenza Operations Technical Development Department at Seqirus.

The high yielding parent strain used was A/Puerto Rico/8/34.

MATERIALS

The following materials of biological origin were used during the preparation of high growth reassortant IVR-202.

Virus Isolate

The virus isolate was obtained from the WHO Collaborating Centre for Reference & Research on Influenza, Melbourne (WHO-CC).

Eggs:

Specific Pathogen Free (SPF) eggs were used for all passages at Seqirus.

Antiserum:

Trypsin-periodate treated sheep hyperimmune antiserum Lot# AS367, Sub-lot # 4968, raised against influenza virus A/Puerto Rico/8/34.

The antiserum was derived from sheep born and raised in Australia.

** Virus sample diluted to 10⁻³ dilution was mixed with antiserum to A/Puerto Rico/8/34 (H1N1) and incubated for 1 hour at room temperature. Incubated virus/antiserum sample was serially diluted and inoculated into eggs at indicated dilution.

Total number of passages post Mixed Infection = 5

Total number of passages since the virus was received from an approved laboratory = 6

Sterility: No visible contamination was detected in a variety of media (tryptose soya broth, thioglycolate broth, Sabouraud's broth and blood agar plates) after 14 days incubation.
