1. INTENDED USE

Reagent 21/166 is prepared from X-355A-CL (H3N2) which was processed in 250µl volumes as liquid stock. The derivation and known passage history of X-355A-CL (H3N2) is attached.

2. CAUTION

This preparation is not for administration to humans or animals in the human food chain

The material is not of human or bovine origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

4. CONTENTS

Country of origin of biological material: United Kingdom. Each vial contains 250µl (nominal) of infectious influenza virus as allantoic fluid from SPF embryonated hen's eggs.

5. STORAGE

Store in the dark at -70°C or below

6. DIRECTIONS FOR OPENING

Vials have a screw cap; an internal stopper may also be present. The cap should be removed by turning anti-clockwise. Care should be taken to prevent loss of the contents. Please note: If a stopper is present on removal of the cap, the stopper should remain in the vial or be removed with the cap.



HA and NA, genes were identified as A/Tasmania/503/2020 by RT-PCR/RFLP gene analysis. The M, PB1, PB2, PA, NS and NP genes were identified as A/PR/8/34 by RT-PCR/RFLP analysis.

SPF eggs were used for all reassortant passages.

Virus seed was shown to be sterile. Sterility testing was performed by streaking the sample on blood agar plates and incubating for 48 hours at 37 °C.
