Reagent 22/140 is prepared from SAN-012 (A/Netherlands/00007/2021 (H3N2) \times A/Puerto Rico/8/1934) which was processed in 250 μ l volumes as liquid stock. The known passage history of SAN-012 is attached.

Vials have a screw cap; an internal stopper may also be present. The cap should be removed by turning anti-clockwise. Care should be taken to prevent loss of the contents. Please note: If a stopper is present on removal of the cap, the stopper should remain in the vial or be removed with the cap.


