Reagent 23/248 was prepared from IVR-243 (H3N2), a reassortant of A/Michigan/60/2022 (H3N2) and A/PR/8/32 (H1N1), which was processed in 250µl volumes as liquid stock. The derivation and known passage history of 23/248 are attached.

Vials have a screw cap; an internal stopper may also be present. The cap should be removed by turning anti-clockwise. Care should be taken to prevent loss of the contents. Please note: If a stopper is present on removal of the cap, the stopper should remain in the vial or be removed with the cap.

Derivation of IVR-243 A/Michigan/60/2022 – like High Growth Reassortant

A/Michigan/60/2022 (IVR-243) is a H3N2 high growth reassortant influenza virus.

PREPARATION

The preparation of A/Michigan/60/2022 (IVR-243) high growth reassortant influenza virus was conducted in Vaccine and PNS Development at CSL Sequrus.

The high yielding parent strain used was A/Puerto Rico/8/34.

MATERIALS

The following materials of biological origin were used during the preparation of high growth reassortant IVR-243:

Virus Isolate:

The virus isolate was obtained from the CDC via Holly Springs, Seqirus.

Supply details are: A/Michigan/60/2022 CDC ID Number: 3030726896 Passages prior to receipt at Seqirus: 3

Eggs:

Specific Pathogen Free (SPF) eggs were used for all passages at CSL Seqirus.

Antiserum:

Trypsin-periodate treated sheep hyperimmune antiserum Lot# AS367 and Sub-lot # 5053, raised against influenza virus A/Puerto Rico/8/34.

The antiserum was derived from sheep born and raised in Australia.

Note on Transmissible Spongiform Encephalopathies (TSEs):
