



Influenza antigen reagent 89/568 is prepared for the single radial diffusion assay of A/OMS/5389/88 (H3N2) (W1C 160) antigens using an appropriate NIBSC antiserum reagent.

2. CAUTION

<u>This preparation is not for administration to humans or animals in the human food chain.</u>

The material is not of human or bovine origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

3. UNITAGE

The solution of the total contents of the ampoule will contain 60 micrograms of haemagglutinin antigen activity.

4. CONTENTS

Country of origin of biological material: United Kingdom.

Antigen Reagent 89/568 is prepared from formalin-inactivated, partially purified A/OMS/5389/88 (H3N2) W1C 160 virus which was suspended in TRIS-HCL buffer containing 1% (w/v) sucrose and processed for freezedrying in 1 ml volumes as described by Campbell P J, Journal of Biological Standardization, 1974, 2, 249-267. The mean weight of 36 ampoules, test weighed was 1.0057g with a coefficient of variation of 0.07%. Antiserum Reagent 89/568 should be used according to the method described by Wood J M, Schild G C, Newman R W and Seagroatt V A, Journal of Biological Standardization, 1977, 5, 237-247, with the following modification:

The reagent has been inactivated following validated procedures used to produce human influenza vaccine that is registered in the EU. This inactivated reagent has been shown to be free from residual infectious virus by testing according to the European Pharmacopeia Compendial Assay (monograph 0158).


5. STORAGE

Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature. -20°C

6. DIRECTIONS FOR OPENING

Tap the ampoule gently to collect the material at the bottom (labelled) end. Ensure ampoule is scored all round at the narrow part of the neck, with a diamond or tungsten carbide tipped glass knife file or other suitable implement before attempting to open. Place the ampoule in the ampoule opener, positioning the score at position 'A'; shown in the diagram below. Surround the ampoule with cloth or layers of tissue paper. Grip the ampoule and holder in the hand and squeeze at point 'B'. The ampoule will snap open. Take care to avoid cuts and projectile glass fragments that enter eyes. Take care that no material is lost from the ampoule and that no glass falls into the ampoule.

7. USE OF MATERIAL

No attempt should be made to weigh out any portion of the material

Antiserum Reagent 89/568 should be used according to the method described by Wood J M, Schild G C, Newman R W and Seagroatt V A, Journal of Biological Standardization, 1977, 5, 237-247, with the following modification:

It is recommended that Antigen Reagent 88/654 and test A/OMS/5389/88 virus antigens should be treated with Zwittergent 3-14 detergent) (Calbiochem-Behring, La Jolla, CA. USA) before single-radial-diffusion assay. Suitable incubation conditions are as follows: 450 microlitres of antigen are added to 50 microlitres of 10% (w/v) Zwittergent detergent and incubated in covered containers for 30 minutes at room temperature (approx. 20°C). Dilutions of detergent-treated antigens are prepared and suitable volumes are added to wells in a single radial diffusion immunoplates.

Antigen Reagent 89/568 should be used to assay A/OMS/5389/88 antigens using antiserum Reagent 88/846.

8. STABILITY

Reference materials are held at NIBSC within assured, temperature-controlled storage facilities. Reference Materials should be stored on receipt as indicated on the label.

NIBSC follows the policy of WHO with respect to its reference materials. Users of the material wishing to refer to the declared ampoule content for use in quantitative or semi-quantitative assay methods should note that the stated content of the material is based on a small collaborative study involving WHO Essential Regulatory Laboratories (ERLs) or Official Medicines Control Laboratories (OMCLs). Studies of recovery and stability of similar antigen preparations indicate that that recovery after ampouling is likely to be close to quantitative, and that no significant loss of content would be expected during storage over at least a 10 year period.
