



**Influenza Reagent  
Influenza anti- A/Guangdong/39/89 (H3N2) HA serum

(Version 4.0, Dated 26/03/2008)**

**1. INTENDED USE**

Influenza antiserum reagent 90/504 is prepared in sheep for the single radial diffusion assay of A/Shanghai/16/89 or A/Guizhuo/54/89 virus antigens.

**2. CAUTION**

**This preparation is not for administration to humans or animals in the human food chain.**

The material is not of human or bovine origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

**3. UNITAGE**

No unitage is assigned to this material.

**4. CONTENTS**

Country of origin of biological material: United Kingdom.

The antiserum was prepared in a SHEEP (SH103) to the purified HA of A/Guangdong/39/89 (H3N2) virus. The HA antigen was extracted from purified virus by treatment with bromelain and purified by sedimentation on sucrose gradients (Brand, C N and Skehel JJ, Nature, New Biology, 1972, 238, 145-147). One dose of approximately 25 micrograms of HA with Freund's complete adjuvant (FCA) were given intramuscularly, followed by three 12.5 microgram doses with FCA at one, two and three week intervals respectively.

Five weeks after the initial immunization, serum was collected, diluted 1:2 with PBS buffer containing sodium azide (0.05% w/v) and filled into vials in 2ml volumes.

**5. STORAGE**

+2-8°C

**Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.**

**6. DIRECTIONS FOR OPENING**

Vials have a 'flip-up' circular cap. Either on the cap or the collar of the vial, there is an indication of the point at which to lever off the cap. This exposes an area of the stopper through which reconstitution and withdrawal of the preparation can be made using a hypodermic needle and syringe. If use of a pipette is preferred, then fully remove the metal collar using, for example, forceps, taking care to avoid cuts by wearing appropriate gloves. Remove the stopper for access. Care should be taken to prevent loss of the contents.

**7. USE OF MATERIAL**

**No attempt should be made to weigh out any portion of the material**

For the assay of A/Shanghai/16/89 or A/Guizhuo/54/89 virus antigens containing 20-50 micrograms of HA activity in 1ml, 20µl of the Reagent should be added to 1ml agarose. Antigens of lower concentration (5-20 micrograms HA/ml) are assayed, by adding 10µl of the Reagent solution to 1ml agarose.

Antiserum Reagent 90/504 should be used according to the method described by Wood, JM, Schild GC, Newman RW and Seagroatt, VA. Journal of Biological Standardisation, 1977, 5, 237-247.

**8. STABILITY**

It is the policy of WHO not to assign an expiry date to their international reference materials. They remain valid with the assigned potency and status until withdrawn or amended.

Reference materials are held at NIBSC within assured, temperature-controlled storage facilities. Reference Materials should be stored on receipt as indicated on the label.
