



**WHO Reference Reagent
1st International Reference Reagent (High Virus Reference) for
MAPREC analysis of poliovirus type 3
NIBSC code: 96/578
Instructions for use
(Version 8.0, Dated 07/12/2015)**

1. INTENDED USE

This WHO International Reference Reagent was established by the WHO Expert Committee on Biological Standardisation at its 1997 meeting. It is intended to be used as a control to determine whether an individual determination is valid in the MAPREC assay. Each assay should additionally include a low virus control, coded 96/572, and the International Standard 95/542. An individual determination is not valid unless 96/578 gives a fail result and 96/572 gives a pass result compared to 95/542.

2. CAUTION

This preparation is not for administration to humans or animals in the human food chain.

The material is not of human or bovine origin.

As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

3. UNITAGE

On the basis of a WHO collaborative study preparation 96/578 has an assigned a value of 1.1% 472-C nucleotide content.

4. CONTENTS

Country of origin of biological material: USA.
Each vial contains approximately 0.5ml of a mixture of poliovirus type 3 (Sabin) grown in serum free medium. A suspension of Hep2 grown virus was spiked with Vero grown virus to produce the bulk suspension that was filled as 96/578.

5. STORAGE

The material should arrive frozen.
Unopened ampoules should be stored at -70°C or below.

6. DIRECTIONS FOR OPENING

Vials have a 'flip-up' circular cap. Either on the cap or the collar of the vial, there is an indication of the point at which to lever off the cap. This exposes an area of the stopper through which reconstitution and withdrawal of the preparation can be made using a hypodermic needle and syringe. If use of a pipette is preferred, then fully remove the metal collar using, for example, forceps, taking care to avoid cuts by wearing appropriate gloves. Remove the stopper for access. Care should be taken to prevent loss of the contents.

7. USE OF MATERIAL

The material should be used as specified in the current version of the Standard Operating Procedure for the MAPREC Assay which is available from Chief, BLG, WHO, Geneva. This procedure requires that an aliquot of 96/578 is tested in each MAPREC assay and used to validate the test.

8. STABILITY

Reference materials are held at NIBSC within assured, temperature-controlled storage facilities. Reference Materials should be stored on receipt as indicated on the label.

NIBSC follows the policy of WHO with respect to its reference materials.
