



**Influenza Reagent**  
**Influenza Antigen A/Sydney/5/97 (H3N2)(IVR-108)**

**Instructions for use**  
**(Version 3.0, Dated 20/03/2008)**

**1. INTENDED USE**

Influenza antigen reagent 99/624 is prepared for single radial diffusion assay of A/Sydney/5/97 (H3N2) (IVR-108) antigens using an appropriate NIBSC antiserum reagent.

**2. CAUTION**

**This preparation is not for administration to humans or animals in the human food chain.**

The material is not of human or bovine origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

**3. UNITAGE**

Antigen reagent 99/624 contains 65 micrograms of haemagglutinin antigen activity.

**4. CONTENTS**

Country of origin of biological material: United Kingdom.  
Antigen Reagent 99/624 is prepared from formalin inactivated, partially purified A/Sydney/5/97 (H3N2)(IVR-108) virus, which was suspended in PBSA buffer containing 1% (w/v) sucrose and processed for freeze-drying in 1ml volumes as described in

The mean weight of 75 ampoules, test weighed was 1.005g with a coefficient of variation of 0.15%

**The reagent has been inactivated following validated procedures used to produce human influenza vaccine that is registered in the EU. This inactivated reagent has been shown to be free from residual infectious virus by testing according to the European Pharmacopeia Compendial Assay (monograph 0158).**

**5. STORAGE**

**Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.**

**6. DIRECTIONS FOR OPENING**

DIN ampoules have an 'easy-open' coloured stress point, where the narrow ampoule stem joins the wider ampoule body. Various types of ampoule breaker are available commercially. To open the ampoule, tap the ampoule gently to collect material at the bottom (labelled) end and follow manufactures instructions provided with the ampoule breaker.

**7. USE OF MATERIAL**

**No attempt should be made to weigh out any portion of the material**

Antigen Reagent 99/624 is prepared from formalin inactivated, partially purified A/Sydney/5/97 (H3N2)(IVR-108) virus, which was suspended in PBSA buffer containing 1% (w/v) sucrose and processed for freeze-drying in 1ml volumes as described in

**8. STABILITY**

Reference materials are held at NIBSC within assured, temperature-controlled storage facilities. Reference Materials should be stored on receipt as indicated on the label. Once reconstituted, diluted or aliquoted, users should determine the stability of the material according to their own method of preparation, storage and use.

Users of the material wishing to refer to the declared ampoule content for use in quantitative or semi-quantitative assay methods should note that the stated content of the material is based on a small collaborative study involving WHO Essential Regulatory Laboratories (ERLs) or Official Medicines Control Laboratories (OMCLs). Studies of recovery and stability of similar antigen preparations indicate that that recovery after ampouling is likely to be close to quantitative, and that no significant loss of content would be expected during storage over at least a 10 year period.
